Meeting Minutes

- 1. Introductions of attending members
- 2. Student Foundation
 - a. Purpose
 - i. Philanthropic organization encouraging students to give back to campus and to related projects
 - b. Constitution review
 - i. Miscellaneous typos: II.A, IV.2.A, VIII.A
 - ii. Article V, Officer Elections: "elected" should really be "selected" in references to Committee Directors. Update to include "Board of Trustees" rather than "Executive Board."
 - iii. Advisor shall "guide" or "advise" meetings.
 - iv. Replace "President" with "CEO."
 - v. Clarify acronyms used for officer positions in the definitions of officer positions.
 - c. Motion to approve pending changes
 - i. Approved
- 3. Student Alumni Association
 - a. Purpose
 - i. Facilitating interactions between students and alumni; enhancing the Georgia Tech experience.
 - b. Constitution review
 - i. In the purpose, "promote the interests of the Georgia Institute of Technology": too broad? Problematic in representing the Institute? Portion of dues will be returned to the Institute to promote its interests. Add "through the philanthropic process" to clarify this.
 - ii. Small edits to IV.IV for clarification.

- iii. IV.III: "and Board Members"—strike. Should it be "Leadership Team"? Reorganize article IV to separate Leadership Team and Executive Board.
- iv. Edit outlining format for consistency throughout the document (capital letters, etc.).
- Many specific duties for officers that would normally appear in by-laws.
 Already in by-laws, so no need to include in the constitution in so much detail.
- vi. Pull VP Operations item about Presidential absence up higher in the list.
- vii. Is the order of officers listed in the constitution succession order? Presumably yes.
- viii. V.Applicants.II: Applications "excluding the President."
- ix. Can shrink V.Applicants.III since conditions appear in the evaluation rubric.
- x. V.Applications.II, setting a deadline for applications in March is too specific.
- xi. Issues with Selection Criteria when only one (other minimum? Two? Three?) person is not seeking reappointment. Open to Committee Chairs.
- xii. Article IX. Overly specific information about dues. Question about "dues" being the appropriate term since the money does not go to SAA. Could call "membership donation" or "membership fee."
- xiii. VII.III: Any "officer or member" can be selected as a committee chair.
- xiv. XI.II: Change "Preamble" to Purpose.
- xv. XIII.I and II: Leadership Team instead of Executive Board.

- a. Purpose
 - American Production and Inventory Control Society. A student chapter of a national organization to help students understand and appreciate the Supply Chain and Logistics concentrations.
- b. Constitution review
 - i. Membership limitation to undergraduate students is problematic. Mission can be to educate undergraduate students without limiting membership. Edit to remove membership restriction.
 - ii. 6.B: "person" > "petition"
 - iii. 5.C typo.
 - iv. 8.B. Change semester-ly reappointment of Advisor to once a year.

5. Enchanted Encounters

a. Purpose

- i. Outreach club for reaching out to local hospitals and volunteering as fictional characters
- ii. Promoting community involvement among Georgia Tech students

b. Constitution review

- i. Strike II.B.
- ii. If you want to allow members to not volunteer, can edit to not require a background check.
- iii. Broaden event-planning requirement for VP External Affairs.
- iv. Strike "PCGB events."
- v. Fundraising and Finance Coordinator: can strike "and Finance."
- vi. Strike the word "active" from V.C.
- vii. Standard edits to Article IX (Dues).
- c. Motion to approve pending changes
 - i. Approved

6. ECE Ambassadors

- a. Purpose
 - i. Departmental organization for ECE
 - ii. Mentoring programs, tours for prospective students, service to the community of ECE students and faculty. Building community within ECE.
- b. Constitution review
 - i. Updated wording in III.C to clarify that a student becomes a member only upon being selected as a tour guide or mentor. Strike C and expand D.
 - ii. IV.3.C: strike references to undergraduates to keep events broadly accessible.
 - iii. Remove requirement for President to be on the Executive Board.
- c. Motion to approve pending changes
 - i. Approved

7. Hellenic Society

- a. Purpose
 - i. Promoting Greek culture and language; connecting Greek students on campus.
- b. Constitution review
 - i. III.V: clarify that attending one meeting each in fall and spring is all that's needed.
 - ii. Reorganize Presidential duties to bullet-point them more evenly.
 - iii. Why the Presidential term limit? To encourage more people to be active.
 - iv. Article VII.IV and V: change President to any officer and "must" to "may" send a final reminder.
 - v. Minor typos.

- vi. The limit on spending in X.I of \$100 is probably too low. \$500 is probably more reasonable.
- vii. Article XIII: better to put in our standard language and just not charge dues, instead of codifying that dues will not be charged.
- viii. Strike XV.I to accommodate situations where multiple amendments are required. Other stopgaps (OSE, SGA reviews of amendments) exist.
- c. Motion to approve pending changes
 - i. Approved

8. DREAM

- a. Purpose
 - i. Increase the number of underrepresented minority students in STEM through team-based competition and mentoring.
- b. Constitution review
 - i. Design with Real Engineers and Mentors = DREAM.
 - ii. II.A: clean up wording in purpose to be consistent with first line.
 - iii. Clarify that Head Mentors do not have to be officers but Board members are expected to be Head Mentors.
 - iv. V.D.a: all Board members not seeking Pres., VP, or Treasurer can help select new Pres., VP, or Treasurer.
 - v. V.E: clarify that no two *officer* positions can be held by the same person.
 - vi. Need a name for Pres., VP, and Treasurer. Leadership Team? Officers?
 - vii. A few small typos.
